You acknowledge that in the event of any breach of your obligations under this letter agreement, the Company shall be entitled to take appropriate disciplinary action against you, including termination of your employment, in addition to any other remedies that are available to the Company.

The invalidity or unenforceability of any provision of this letter agreement shall not affect the validity or enforceability of any other provisions of this letter agreement, which shall remain in full force and effect. The agreements set forth in this letter agreement may be modified or waived only by a separate writing executed by the Company. No failure or delay by the Company in exercising any right, power or privilege hereunder will operate as a waiver thereof, nor will any single or partial exercise thereof preclude any other or further exercise of any right, power or privilege hereunder. This letter agreement supplements, and does not supersede, any other existing covenants that you have with the Company concerning non-disclosure of confidential and proprietary information.

This letter agreement is solely for the benefit of the Company and its assigns and will be governed by and construed in accordance with the laws of the State of Texas, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws.
